



We have reviewed the correspondence and we want to assure all educators that each section has been scrutinized by the Association and we are aware that some of the wording may cause confusion.

The DECD FDC Business and Customer Support Centre has included much of this information in their 2013 training sessions which was available throughout the State.

Allow us to highlight 3.a

Charging Fees on page 3

where it states :-

"Your service operator is responsible for setting a fee charging schedule and establishing fee charging policies".

Deb Barton and Elke Evele are preparing a written policy which is now a requirement to meet the expectations of the National Regulations.

Please be assured that Educators will still set their own fee charging schedule.



It is recommended that you book training well in advance to ensure that your Scheme has a renewed current certificate in their office to avoid being in breach of your conditions.
